英文契約書訂正の仕方

・署名前の訂正

英文契約書訂正については、署名前であれば、タイプし直すことが原則であるが、契約書作成後、タイプし直す時間がないとかで、作成済みの契約書に訂正を加える方法は次のようにします。

- ①削除や訂正箇所が読めるように二重線や一重線を引く。
- ②署名欄の両者のイニシャルを、訂正や追加箇所又はその行端に自筆で記す。
- ③パラグラフや条項全文の削除は、パラグラフや条項文全体に掛けて×を記し、条項番号はそのままにする。
